ORDER

On January 9, 2014, the Commission accepted for filing the joint application of W & W Service Co.<sup>1</sup> ("W & W") and the Paducah-McCracken County Joint Sewer Agency ("JSA") to transfer control of the Terre Verte Subdivision sewage treatment and collection system to JSA. The Commission issued an Order on March 6, 2014, approving the transfer of control of the Terre Verte Subdivision sewage treatment and collection system subject to four conditions identified in the Order.

On July 18, 2014, the Commission issued an Order granting the parties' request for an extension of time to September 30, 2014, to comply with Ordering paragraph 3 of the March 6, 2014 Order.<sup>2</sup> The parties have now requested that they be given up to and including December 31, 2014, to complete the connection and transfer of control of the Terre Verte Subdivision sewage treatment and collection system to JSA.

The parties state that they experienced unanticipated delays due to wetlands mitigation and environmental issues regarding the presence of the Indiana bat on part of the property. Delays were also incurred in obtaining the necessary easements.

Having reviewed the Orders of March 6, 2014, and July 18, 2014, and the parties' motion, and being otherwise advised, the Commission finds that W & W and JSA should have until December 31, 2014, to execute and implement the proposed transfer of control.

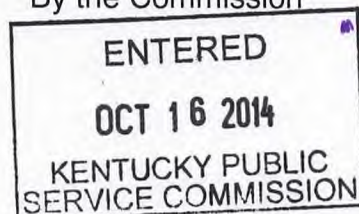
IT IS THEREFORE ORDERED that:

1. Movants' motion for an extension to execute and implement the proposed transfer of control of the Terre Verte Subdivision sewage treatment and collection system is granted.

2. Ordering paragraph 3 of the March 6, 2014 Order as modified in the July 18, 2014 Order is further modified to the limited extent that W & W and JSA shall have until December 31, 2014, to execute and implement the transfer of control proposed in the application.

3. All other provision of the Commission's March 6, 2014 Order as modified by the July 18, 2014 Order shall remain in full force and effect.
