ORDER

On February 20, 2014, the Commission issued an Order establishing a procedural schedule in this matter. The Order required requests for, or waiver of, a hearing to be filed no later than May 5, 2014. On April 18, 2014, East Kentucky Power Cooperative, Inc. ("EKPC") submitted a motion to schedule an informal conference ("IC"), to occur prior to the May 5, 2014 deadline to request a hearing. It further requested that the IC be scheduled in conjunction with a requested IC in Case No. 2014-00047.<sup>1</sup> After confirming an IC date of May 7, 2014, with Commission Staff on April 28, 2014, EKPC submitted a motion requesting an extension of time within which to request a hearing up to and including May 8, 2014. In support, EKPC states that an IC has been scheduled for May 7, 2014, and it believes the course of the IC will impact its determination as to the necessity of a formal hearing.

The Commission, having considered EKPC's motion, finds that an IC should be scheduled for May 7, 2014. The Commission further finds that good cause exists to grant a three-day extension within which to request a hearing in this matter.

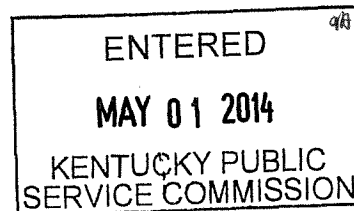

1. EKPC's motion for an IC is granted.
2. An IC shall be held on Wednesday, May 7, 2014, at 1:30 p.m. Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of discussing the issues in this case.
3. EKPC's motion for an extension of time is granted.
4. Any request for an evidentiary hearing or any request for waiver of a hearing shall be filed no later than May 8, 2014.
