ORDER

On June 23, 2014, Cumberland Valley Electric, Inc. ("Cumberland Valley") submitted an application for an adjustment of rates based upon a historical test period. It proposed that the new rates become effective on July 22, 2014. On July 10, 2014, the Commission issued an Order wherein it suspended the proposed rates for a period of five months up to and including December 22, 2014. The July 10, 2014 Order further set forth a procedural schedule requiring requests for intervention to be filed no later than July 14, 2014, and initial requests for information to Cumberland Valley to be filed no later than July 24, 2014. On July 14, 2014, the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, ("AG") moved for intervention in this action. The motion was granted on July 23, 2014.

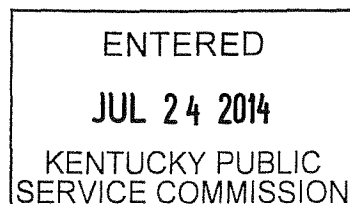
On July 22, 2014, the AG submitted a motion for an extension of time within which to file initial requests for information. In support, the AG states that his evaluation of the issues presented in the case will require more than the allotted ten days between the dates for intervention and submission of information requests. The AG represents that counsel for Cumberland Valley does not object to the extension and proposes

moving the entire procedural schedule back by two weeks, but not otherwise impacting the suspension date.


The Commission finds that the AG has demonstrated good cause for an extension of time. The Commission further finds that the procedural schedule in this matter should be modified and HEREBY ORDERS that:

1. The AG's motion for an extension of time to submit initial requests for information to Cumberland Valley and to extend the procedural schedule by two weeks is granted.
2. The procedural schedule set forth in the Appendix to the Commission's July 10, 2014 Order is supplanted by the procedural schedule attached as an Appendix to this Order.
3. All other provisions of the Commission's July 10, 2014 Order not in conflict with this Order shall remain in full force and effect.
