ORDER

On December 2, 1999, in Case No. 1999-00312, the Commission approved rates for Millennium Energy, Inc. ("Millennium") and provided for their further adjustment in accordance with Millennium's Gas Cost Adjustment clause.¹

On May 23, 2014, Millennium filed its proposed Gas Cost Recovery Rate ("GCR") application to be effective July 1, 2014.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium's notice includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Millennium's notice sets out an Expected Gas Cost ("EGC") of \$4.930495 per Mcf. Rounding the EGC to four decimal places produces an EGC of \$4.9305 per Mcf, which is a decrease of \$.7520 per Mcf from its previous EGC of \$5.6825 per Mcf.
3. Millennium's notice sets out no Refund Adjustment.
4. Millennium's notice sets out a current quarter Actual Adjustment ("AA") of \$1.5039 per Mcf. Millennium's total AA is \$1.7374 per Mcf, which is an increase of

\$1.4618 per Mcf from the previous total AA of \$.2756 per Mcf.

5. Millennium's notice sets out a current quarter Balance Adjustment ("BA") of \$.006191 per Mcf. Millennium's total BA is \$.0086 per Mcf, which is an increase of \$.0022 per Mcf from the previous total BA of \$.0064 per Mcf.

6. Millennium's notice sets out a GCR of \$6.67652 per Mcf. Rounding the GCR calculation to four decimal places produces a GCR of \$6.6765 per Mcf, which is an increase of \$.7120 per Mcf from the previous GCR of \$5.9645 per Mcf.

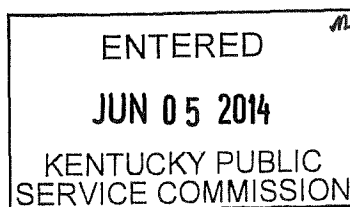
7. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after July 1, 2014.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix to this Order are approved for service rendered on and after July 1, 2014.
