ORDER

On December 2, 1999, in Case No. 1999-00312,¹ the Commission approved rates for Millennium Energy, Inc. (“Millennium”) and provided for their further adjustment in accordance with Millennium’s Gas Cost Adjustment clause.

On August 22, 2014, Millennium filed its proposed Gas Cost Recovery Rate (“GCR”) application to be effective October 1, 2014.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium’s notice includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Millennium’s notice sets out an Expected Gas Cost (“EGC”) of \$4.5134 per Mcf, which is a decrease of \$.4171 per Mcf from its previous EGC of \$4.9305 per Mcf.
3. Millennium’s notice sets out no Refund Adjustment.

4. Millennium's notice sets out a current quarter Actual Adjustment ("AA") of \$.0163 per Mcf. Millennium's total AA is \$1.7822 per Mcf, which is an increase of \$.0448 per Mcf from the previous total AA of \$1.7374 per Mcf.

5. Millennium's notice sets out a current quarter Balance Adjustment ("BA") of \$.002625 per Mcf. Millennium's total BA is \$.0074 per Mcf, which is a decrease of \$.0012 per Mcf from the previous total BA of \$.0086 per Mcf.

6. Millennium's notice sets out a GCR of \$6.3030 per Mcf, which is a decrease of \$.3735 per Mcf from the previous GCR of \$6.6765 per Mcf.

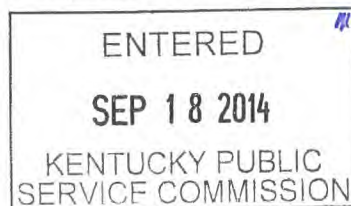
7. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after October 1, 2014.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for service rendered on and after October 1, 2014.

2. Within 20 days of the date of this Order, Millennium shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
