### <u>ORDER</u>

On July 2, 2015, the Commission entered an Order in this matter establishing new rates for Kentucky-American Water Company. However, Appendix B to the July 2, 2015 Order contained an erroneous rate. Specifically, the rate for Rockwell Village for over 12,000 gallons was set forth as ".2504 per 100 gallons." This rate should be stricken and substituted with ".2213 per 100 gallons."

The Commission finds that:

- 1. Appendix B to the July 2, 2015 Order should be amended to reflect the correct rate for Rockwell Village as set forth in the Amended Appendix B to this Order.
- 2. Kentucky-American Water Company should be given 20 days of entry of this Order to comply with ordering paragraph 10 of the July 2, 2015 Order regarding the filing of tariffs.

IT IS THEREFORE ORDERED, nunc pro tunc, that:

- 1. Appendix B of the July 2, 2015 Order is stricken and is replaced by the Amended Appendix B attached to this Order.
- 2. Kentucky-American Water Company shall have 20 days after entry of this Order, using the Commission's electronic Tariff Filing System, to:

- File a separate and distinct tariff for its sewer service;
- b. Include the rates and effective date for all four phases in the separate and distinct sewer service tariff; and
  - c. Remove from its water tariff any pages referencing sewer services.
- 3. All provisions of the July 2, 2015 Order that are not in conflict with the terms of this Order shall remain in effect.
