ORDER

On February 5, 2015, the Commission issued an Order initiating this proceeding to review East Kentucky Power Cooperative, Inc.'s ("EKPC") fuel adjustment clause for the two-year period from November 1, 2012, through October 31, 2014. The February 5, 2015 Order established a deadline of February 20, 2015, for EKPC to file its direct testimony and responses to the requests for information contained in Appendix B of that Order. On February 18, 2015, EKPC filed a motion requesting an extension of four business days, or until February 26, 2015, to file its direct testimony and discovery responses. EKPC states that the recent and widespread inclement winter weather has impacted its ability to timely compile and finalize its discovery responses. EKPC states that the relatively brief extension of time will not result in prejudice or unreasonable delay.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that EKPC has established good cause to permit it a brief extension of time in which to file its direct testimony and discovery responses. The Commission further finds that the deadlines established in the February 5, 2015 Order regarding the

issuance of interrogatories and requests for production of documents on EKPC and EKPC's responses thereto should also be revised.

IT IS HEREBY ORDERED that:

- 1. EKPC's motion for an extension of time is granted.
- 2. All parties shall adhere to the procedural schedule set forth in the appendix to this Order.
- 3. All other provisions of the Commission's February 5, 2015 Order shall remain in full force and effect.
