## <u>ORDER</u>


The matter is before the Commission upon a request filed by Big Rivers Electric Corporation, Kentucky Industrial Utility Customers, Inc., and the Attorney General of the Commonwealth of Kentucky (collectively "the Parties") to have the procedural schedule be suspended.<sup>1</sup> In support of the request, the Parties have informed the Commission that a tentative settlement has been reached and the Parties need time to finalize the settlement agreement for submission to the Commission.

Having reviewed the request and being otherwise sufficiently advised, the Commission finds that the Parties have established good cause to permit the suspension of the current procedural schedule with respect to the deadline of May 22, 2015, for Big Rivers to file its rebuttal testimony.
