ORDER

On April 8, 2015, Magoffin County Water District ("Magoffin County") applied for an adjustment of its rates for service pursuant to the procedures set forth in 807 KAR 5:076. After Magoffin County corrected filing deficiencies, its application was accepted for filing on May 4, 2015. The Commission finds that a procedural schedule should be established to ensure the orderly review of Magoffin County's application.¹

IT IS THEREFORE ORDERED that:

- 1. No later than August 4, 2015, Commission Staff shall file with the Commission and serve upon all parties of record a written report containing its findings and recommendations regarding Magoffin County's requested rate adjustment.
- No later than August 18, 2015, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, each party of record shall file with the Commission:
- a. Its written comments on and any objections to the findings and recommendations contained in the Commission Staff Report; and

¹ No action is necessary to suspend the effective date of Magoffin County's proposed rates for general water service. Pursuant to 807 KAR 5:076, Section 7(1), an applicant who applies for a rate adjustment pursuant to the procedures set for in 807 KAR 5:076 may not place its proposed rates into effect until the Commission approves those rates or six months from the date of the filing of its application.

- b. Any additional evidence for the Commission to consider.
- c. If a party requests a hearing or informal conference, then the party shall make the request in its written comments and state the reason why a hearing or informal conference is necessary.
- 3. If Commission Staff finds that Magoffin County's financial condition supports a higher rate than Magoffin County proposes or the assessment of an additional rate or charge not proposed in Magoffin County's application, Magoffin County in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the recommended additional rate or charge.
- 4. If Commission Staff recommends changes in the manner in which Magoffin County accounts for the depreciation of Magoffin County's assets, Magoffin County in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should require Magoffin County to implement the proposed change for accounting purposes.
- 5. A party's failure to file written objections to a finding or recommendation contained in the Commission Staff Report by August 18, 2015, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, shall be deemed a waiver of all objections to that finding or recommendation.
- 6. A party's failure to request a hearing or informal conference in the party's written response shall be deemed a waiver of all rights to a hearing on the application and a request that the case stand submitted for decision.

- 7. A party's failure to file a written response by August 18, 2015, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, shall be deemed a waiver of all rights to a hearing on the application.
 - 8. Any motion to intervene shall be filed no later than June 8, 2015.
- 9. A person who submits a motion to intervene after June 8, 2015, and upon a showing of good cause is granted full intervention shall accept and abide by the existing procedural schedule.
