ORDER

On August 14, 2015, the Commission entered an Order that established a revised procedural schedule for this case that includes a formal hearing in this matter to be held on September 8, 2015. The revised Order of procedure required, among other things, that the city of Augusta ("Augusta") pre-file with the Commission, on or before August 21, 2015, the testimony of each witness that it intends to call at the September 8, 2015 hearing. Bracken County Water District ("Bracken District"), the only intervenor in this action, was, by the same Order, required to pre-file with the Commission, on or before August 21, 2015, the testimony of each witness that it intends to call at the September 8, 2015 hearing.

On August 20, 2015, Augusta and Bracken District filed a Joint Motion to Modify Procedural Schedule through which the parties seek an extension of time for submitting testimony from August 21, 2015, to August 27, 2015.¹ The parties stated that the additional time is necessary to complete the preparation of the required testimonies. The parties do not seek to revise the date for the hearing in this matter.

Having reviewed the motion, and being otherwise sufficiently advised, the Commission finds good cause to grant the requested extension of time.

 2015.
- 3. All provisions of the August 14, 2015 Order that are not in conflict with the terms of this Order shall remain in effect.
- 4. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
