ORDER

On August 14, 2015, the Commission entered an Order that established a revised procedural schedule for this case that included, among other things, an informal conference in this matter to be held on September 1, 2015, and a formal hearing in this matter to be held on September 8, 2015.¹ On August 20, 2015, the city of Augusta ("Augusta") and the Bracken County Water District ("Bracken District") filed a Joint Motion to Modify Procedural Schedule, and on August 28, 2015, the Commission entered an Order which granted both parties an extension of time from August 21, 2015, to August 27, 2015, for submitting pre-filed testimony.

On August 25, 2015, while the Joint Motion to Modify Procedural Schedule was pending, Bracken District filed a motion for a second modification of the procedural schedule.² Specifically, Bracken District stated that its counsel had a scheduling conflict

On August 28, 2015, Augusta filed a Motion to Amend for Rate Case Expense, and on August 31, 2015, Bracken District filed a Motion to Declare the Initial Rate Filing Void, Suspend the Amended Rate Filing, and Modify the Existing Procedural Schedule. Pursuant to 807 KAR 5:001, Section 2, Augusta has seven days from the date of the filing of the Bracken District Motion to respond. The Commission will, therefore, address these two additional motions by a separate Order.

on September 1, 2015, and it requested that the informal conference set for September 1, 2015, be rescheduled.

Having reviewed the motion, and being otherwise sufficiently advised, the Commission finds good cause to grant the motion to reschedule the informal conference.

IT IS HEREBY ORDERED that:

- Bracken District's motion to modify the procedural schedule to reschedule the informal conference is granted.
 - 2. The informal conference scheduled for September 1, 2015, is cancelled.
- 3. An informal conference shall be held on September 2, 2015, at 1:00 p.m. Eastern Daylight Time in the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of considering the possibility of settlement, the simplification of issues, and any other matters that may aid in the handling or disposition of this case.
- 4. All provisions of the August 14, 2015 Order that are not in conflict with the terms of this Order shall remain in effect.
- 5. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
