ORDER

This matter arises upon the motion of Kentucky Industrial Utility Customers, Inc. ("KIUC"), filed May 27, 2015, for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission, being otherwise sufficiently advised, finds that KIUC should be granted full rights of a party in this proceeding.

IT IS HEREBY ORDERED that:

1. The motion of KIUC to intervene is granted.
2. KIUC shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
3. KIUC shall comply with all provisions of the Commission's regulations, 807 KAR 5:001, Section 8, related to the service and electronic filing of documents.


4. Pursuant to 807 KAR 5:001, Section 8(9), KIUC shall file with the Commission, within seven days from the date of this Order, a written statement, with a copy to parties of record, that:

a. KIUC waives its right to service of any Commission Order by mail for purposes of this proceeding only.

b. KIUC certifies that it or its agent possesses the facilities to receive electronic transmissions.

c. Sets forth the electronic mail address to which all electronic notices and messages related to this proceeding should be served.
