ORDER

On May 21, 2015, Lake Village Water Association, Inc. ("Lake Village") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Lake Village purchases water from the city of Danville ("Danville") and the city of Harrodsburg ("Harrodsburg").
- 2. Danville notified Lake Village that effective May 1, 2015, Danville would increase its wholesale rate subject to refund² to Lake Village from a declining block rate schedule to a flat rate of \$2.41 per 1,000 gallons. Lake Village proposed to increase the water rates to its customers effective May 15, 2015, to reflect the increased cost of purchased water.
- 3. Should the Commission approve a rate lower than currently proposed and implemented subject to refund by Danville, Lake Village should file a revised purchased water adjustment within 30 days of the Commission's Order in Case No. 2014-00392.³

- 4. Lake Village proposed a purchased water adjustment factor of \$0.70⁴ per 1,000 gallons.
- 5. During the 12 months ended April 30, 2015, Lake Village purchased 163,983,591 gallons of water from Danville and 64,411,088 gallons of water from Harrodsburg, and sold 181,072,496 gallons of water. The increase in the cost of purchased water is \$126,225.82, resulting in a purchased water adjustment of \$0.70 per 1,000 gallons.
- 6. The purchased water adjustment factor of \$0.70 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 7. Lake Village's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved subject to refund for water service rendered on and after May 15, 2015.

IT IS THEREFORE ORDERED that:

- The purchased water adjustment factor of \$0.70 per 1,000 gallons is approved subject to refund.
- 2. Lake Village's proposed rates, as set forth in Appendix B to this Order, are approved subject to refund for water service rendered on and after May 15, 2015.
- 3. Within 20 days of the date of this Order, Lake Village shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein subject to refund.

4. Lake Village shall file a revised purchased water adjustment within 30 days of the Commission's Order in Case No. 2014-00392 approving a rate increase for Danville if the approved rate for Danville differs from the rates implemented subject to refund by Danville.
