ORDER

On July 30, 2015, Louisville Gas and Electric Company ("LG&E") moved the Commission for an extension of time, from July 31, 2015, to August 12, 2015, in which to file its testimony and responses to the July 10, 2015 information requests. In support, LG&E states that the additional time is necessary due to the existing workload and vacation schedules of those employees involved in the information's preparation.

The Commission, having considered LG&E's motion, finds that good cause exists to grant the motion. The Commission further finds that the procedural schedule in the Appendix to the July 10, 2015 Order should be amended to accommodate the time extension.

IT IS THEREFORE ORDERED that:

1. LG&E's motion is granted.
2. LG&E is granted an extension of time to file its testimony and responses to the July 10, 2015 information requests up to and including August 12, 2015.

3. The procedural schedule set forth in the Appendix to this Order shall be followed.

4. All provisions of the Commission's July 10, 2015 Order not in conflict with this Order shall remain in full force and effect.
