## ORDER

On July 8, 2015, BellSouth Telecommunications, LLC d/b/a AT&T Kentucky ("AT&T Kentucky") filed a petition for a declaratory order to determine the obligations of AT&T Kentucky and Central Kentucky 911 Network ("CKN") regarding interconnection and routing of traffic for the provision of 911 service to Public Safety Answering Points. On July 31, 2015, the Commission issued an Order directing AT&T Kentucky to serve its petition, *inter alia*, upon the Kentucky Commercial Radio Service Board and all incumbent local exchange carriers in Kentucky because the issues raised in the petition could have statewide implications for 911 services. In the July 31, 2015 Order, the Commission established a procedural schedule that provided for responses to the petition for declaratory order to be filed no later than August 26, 2015, and for AT&T Kentucky to file replies to responses no later than September 9, 2015. On August 25, 2015, London Laurel County Communication Center filed a motion requesting an extension of time until September 11, 2015, to file a response to the petition for declaratory order.

As a basis for its motion, London Laurel County Communication Center states that it was not aware of this matter until August 19, 2015, and that its counsel became aware of this matter on August 24, 2015. London Laurel County Communication Center argues that it is directly affected by this matter and is referenced in paragraph 9 of the petition. London Laurel County Communication Center further argues that it cannot adequately respond to the petition prior to the date established in the procedural schedule.

Having considered the motion and being otherwise sufficiently advised, the Commission finds good cause to grant the motion and modify ordering paragraphs 2 and 4 of the July 31, 2015 Order.

IT IS THEREFORE ORDERED that:

1. London Laurel County Communication Center's motion for an extension of time is granted.

2. Ordering paragraph 2 of the July 31, 2015 Order is amended to read as follows:

Responses to the petition for declaratory order, if any, shall be filed no later than September 11, 2015.

3. Ordering paragraph 4 of the July 31, 2015 Order is amended to read as

follows:

Replies to responses, if any, shall be filed no later than September 25, 2015.
