ORDER

The matter is before the Commission upon a motion filed by East Kentucky Power Cooperative, Inc. ("EKPC") requesting that a formal hearing be scheduled for the instant matter. In support of its motion, EKPC states that the October 2, 2015 deadline for the filing of intervenor testimony has expired and no intervenor testimony has been filed in this matter. EKPC also states that since no intervenor testimony has been filed, it does not intend to propound any discovery requests upon the intervenors and does not intend to file rebuttal testimony. In light of the procedural posture of this case and EKPC's requests for a decision by December 1, 2015, EKPC moves the Commission to schedule a formal hearing as soon as practicable.

Having reviewed EKPC's motion and being otherwise sufficiently advised, the Commission finds that EKPC's request is reasonable and a formal hearing will be scheduled for November 4, 2015.

IT IS THEREFORE ORDERED that:

1. A hearing in this matter shall be held on Wednesday, November 4, 2015, at 10:00 a.m. Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

2. The official record of these proceedings shall be by video only.

3. Any request to cancel or postpone this hearing shall be made by motion filed with the Commission at least one week before the hearing is scheduled to commence.

4. At the public hearing in this matter, neither opening statements nor summarization of direct testimonies shall be permitted.
