## ORDER

On September 15, 2016, the Commission issued an Order in this matter denying the rates proposed by Kenergy Corp. ("Kenergy") and approving new rates as set forth in the Appendix to that Order. Findings paragraph 1 and ordering paragraph 2 of that Order stated that the new rates are to be charged "on and after the date of this Order."

The Commission, on its own motion, finds that Kenergy had filed a letter on May 18, 2016, stating its intent to implement its proposed rates on May 20, 2016, upon the expiration of the rate suspension period. Consequently, the new rates approved on September 15, 2016, should have been effective for service rendered on and after May 20, 2016, and the provisions of the September 15, 2016 Order to the contrary are erroneous. Thus, findings paragraph 1 and ordering paragraph 2 of the September 15, 2016.

IT IS THEREFORE ORDERED, nunc pro tunc, that:

1. Finding paragraph 1 of the September 15, 2016 Order is stricken and is replaced with the following language:

The rates set forth in Appendix A are the fair, just, and reasonable rates for Kenergy to charge for service rendered on and after May 20, 2016.

2. Ordering paragraph 2 of the September 15, 2016 Order is stricken and is replaced with the following language.

The rates set forth in the Appendix to this Order are approved for services rendered by Kenergy on and after May 20, 2015.

3. All provisions of the September 15, 2016 Order that are not in conflict with

the terms of this Order shall remain in effect.
