
<u>ORDER</u>

The Commission's December 16, 2015 Order established a procedural schedule for the processing of this case, providing for two rounds of information requests, intervenor testimony, and an information request to intervenors. No intervenor testimony was filed.¹ Discovery having been completed, the Commission must now determine whether a hearing is needed or whether the matter can be decided upon the evidence of record.

IT IS THEREFORE ORDERED that, no later than seven days from the date of this Order, the parties to this matter shall file a statement as to whether there are any material issues of fact that warrant a hearing, or whether this case may be submitted for adjudication based on the existing record without a hearing.

¹ Wallace McMullen and the Sierra Club filed testimony and requested intervention in this proceeding. However, the intervention request was denied by the Commission, and the testimony was deemed to be public comment.
