## ORDER

On December 9, 2015, the Commission entered an Order which, among other things, established a procedural schedule for the processing of the instant matter. The procedural schedule provided for a deadline to request intervention and allowed for two rounds of discovery on Kentucky Power Company's application. The Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, is the only intervenor in this matter. The Commission, sua sponte, finds that the current procedural schedule should be amended to allow the parties to this matter an opportunity to file comments related to Kentucky Power's application so that the record for this case can be further developed, which would assist the Commission in fully considering this matter.

IT IS HEREBY ORDERED that:

1. The current procedural schedule established pursuant to the Commission's December 9, 2015 Order is amended as follows:
a. Intervenor comments, if any, shall be filed no later than March 11, 2016.
b. Kentucky Power's rebuttal comments, if any, shall be filed no later than March 18, 2016.
c. Parties shall file a request for an evidentiary hearing, supported by a detailed statement of factual issues to be raised therein, or a request that the matter can be decided on the record no later than March 25, 2016.
2. All other provisions of the December 9, 2015 Order that are not in conflict with the terms of this Order shall remain in full force and effect.
