ORDER

On December 21, 2015, the Commission issued an Order initiating a six-month review of Louisville Gas And Electric Company's ("LG&E") environmental surcharge for the billing period ending October 31, 2015. With its Order, the Commission attached its First Request for Information as Appendix B. On its own motion, the Commission finds that Item 1 to Appendix B requests information as of an incorrect date of October 31, 2015, instead of the correct date of August 31, 2015. It is therefore ordered that:

1. The first sentence of Item 1, on page 1 of Appendix B to the Commission's December 21, 2015 Order, is amended to read:

Concerning the rate of return on the 2009 and 2011 amendments to the environmental compliance plan, for the period under review, calculate any true-up adjustment needed to recognize changes in LG&E's cost of debt, preferred stock, accounts receivable financing (if applicable), or changes in LG&E's jurisdictional capital structure as of August 31, 2015.

2. All other provisions of the Commission's December 21, 2015 Order not in conflict with this Order shall remain in full force and effect.
