ORDER

On December 14, 2015, South 641 Water District ("South 641") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹ The Commission, having reviewed the record and being sufficiently advised, finds that:

- South 641 purchases water from the city of Murray Water and Sewer System ("Murray").
- 2. On July 1, 2015, Murray notified South 641 that it would increase its wholesale rate to South 641 from \$1.83 per 1,000 gallons to \$2.01 per 1,000 gallons effective on January 1, 2016.² South 641 proposed to increase the water rates to its customers effective January 1, 2016, to reflect the increased cost of purchased water.
- 3. South 641 proposed a purchased water adjustment factor of \$0.19 per 1,000 gallons.
- 4. During the 12 months ended September 30, 2015, South 641 purchased 17,823,950 gallons of water from Murray and sold 17,025,110 gallons. The increase in the cost of purchased water is \$3,208.31, resulting in a purchased water adjustment factor of \$0.19 per 1,000 gallons.

- 5. The purchased water adjustment factor of \$0.19 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 6. South 641's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered on and after January 1, 2016.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.19 per 1,000 gallons is approved.
- 2. South 641's proposed rates are approved, as set forth in Appendix B to this Order, for water service rendered on and after January 1, 2016.
- 3. Within 20 days of the date of this Order, South 641 shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
