## ORDER

On April 1, 2016, the Commission entered an Order that scheduled a hearing on July 12, 2016, for the purpose of taking evidence on Kentucky-American Water Company's ("KAWC") application. The Commission finds, on its own motion, that the hearing should be rescheduled to July 13, 2016, at 10:00 a.m. Eastern Daylight Time. We further find that a public meeting for the purpose of taking public comment on KAWC's proposed rate adjustment should be held on June 7, 2016, at the Bluegrass Community and Technical College's Conference Center at its Leestown Road Campus.

IT IS HEREBY ORDERED that:


1. The hearing for the purpose of taking evidence on KAWC's application scheduled for July 12, 2016, is rescheduled to July 13, 2016, at 10:00 a.m. Eastern Daylight Time.

2. A public meeting for the purpose of providing general information about this proceeding and KAWC's proposed rate adjustment and for taking public comment on KAWC's proposed rate adjustment shall be held on June 7, 2016, beginning at 5:30 p.m., Eastern Daylight Time, at Bluegrass Community and Technical College, Conference Center, Leestown Road Campus, 164 Opportunity Way, Lexington, Kentucky.

3. KAWC shall publish notice of the scheduled hearing in accordance with 807 KAR 5:001, Section 9(2)(b)2, not less than seven nor more than 21 days prior to the day of the scheduled hearing. In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov." At the time the notice is mailed or publication is requested, KAWC shall forward a duplicate of the notice and request to the Commission.

4. All other provisions of the Commission's April 1, 2016 Order not in conflict with the provisions of this Order shall remain in full force and effect.
