ORDER

The matter is before the Commission upon a motion filed by South Kentucky Rural Electric Cooperative Corporation ("South Kentucky") requesting leave to amend a portion of its application. In support of its motion, South Kentucky states that Exhibit 2 – Attachment B, pages 3 of 8, 5 of 8, and 7 of 8 incorrectly listed the Net Present Value as \$16,537,472. South Kentucky states that the correct figure is \$6,377,575. Attached to South Kentucky's motion are versions of Exhibit 2 – Attachment B, pages 3 of 8, 5 of 8, and 7 of 8 that contain the correct Net Present Value. South Kentucky requests that it be allowed to substitute the pages containing the correct information which are attached to its motion for the corresponding pages in its originally filed application.

Having reviewed South Kentucky's motion and being otherwise sufficiently advised, the Commission finds that South Kentucky has established good cause for leave to amend its application by substituting the corrected Exhibit 2 – Attachment B, pages 3 of 8, 5 of 8, and 7 of 8 to the application.

IT IS THEREFORE ORDERED that South Kentucky's motion to amend its application is granted and the corrected Exhibit 2 – Attachment B, pages 3 of 8, 5 of 8, and 7 of 8 attached to South Kentucky's motion is substituted for the original filed with the application.
