ORDER

This matter is before the Commission upon a petition filed by WKG Storage, Inc. ("WKG") and Atmos Energy Corporation ("Atmos") (jointly, "the Companies"), pursuant to KRS 278.400, requesting a rehearing to correct the rates granted WKG by the Commission in its September 30, 2016 Order. The Commission's September 30, 2016 Order granted rates for natural gas injection, withdrawal and reservation from WKG's East Diamond Gas Storage Field located in Hopkins County, Kentucky.

In support of the petition, the Companies state that the September 30, 2016 Order does not apply Atmos's discount prior to developing the rates. Along with the petition, the companies provided an exhibit with WKG's proposed rates reflecting the discounts. The Commission has considered the Companies' request and finds that rehearing is warranted. Therefore, a rehearing is being granted for the purpose of approving WKG's request to replace the rates approved in the Commission's September 30, 2016 Order with the rates contained in its request for rehearing.

FINDINGS

After review of the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- The Companies' petition for rehearing should be granted.
- The rates in the Appendix attached hereto are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- The Companies' motion for rehearing is granted.
- The rates in the Appendix attached hereto are approved for service WKG renders on and after the date of this Order.
- 3. Within 20 days of the date of this Order, WKG shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and reflecting their effective date and that they were authorized by this Order.
- All other provisions of the Commission's September 30, 2016 Order not in conflict with this Order shall remain in full force and effect.
