COMMISSION STAFF'S INITIAL REQUEST FOR INFORMATION  
TO DEXTER-ALMO HEIGHTS WATER DISTRICT

Dexter-Almo Heights Water District ("Dexter-Almo"), Pursuant to 807 KAR 5:001, is to file with the Commission the original and ten copies of the following information, with a copy to all parties of record. The information requested herein is due within 14 days from the date of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Dexter-Almo shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which

Dexter-Almo fails or refuses to furnish all or part of the requested information, Dexter-Almo shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, Dexter-Almo shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Explain Dexter-Almo's plans regarding its ability to meet water storage requirements in its system over the next 5 years.
2. For the city of Murray ("Murray") water system:
  - a. State the average daily demand of Murray's customers.
  - b. State the annual amount of water Murray sells to other water systems and identify each system.
  - c. Identify all water storage requirements Murray is required to meet.
  - d. Identify all water storage tanks in the Murray water system and their capacities.
  - e. Is Murray willing to allocate storage from its system in the water purchase contract with Dexter-Almo?

3. For the connections to Dexter-Almo by Murray:
  - a. State the number of connections between Murray and Dexter-Almo.
  - b. Identify the closest Murray tank, the tank's capacity and the distance to each connection point.
  - c. State whether any of these connections are pumped.
  - d. Identify the capacity of the pumps and the distance from the pumps to the connection.
  - e. Identify the pumps with back-up power.
