

On April 8, 2016, the Commission issued an Order establishing a procedural schedule for the processing of this matter. The procedural schedule provided for, among other things, one round of discovery and a deadline of May 17, 2016, for the filing of intervenor testimony. To date, discovery has been completed and no intervenor testimony has been filed. On May 20, 2016, the joint applicants, Big Rivers Electric Corporation and Kenergy Corp., filed a letter stating that neither would be filing rebuttal testimony or comments and that "subject to any hearing that may be ordered, their case is complete and submitted to the Public Service Commission." The Commission must now determine whether the intervenors believe that a hearing is needed or whether they agree that this matter can be decided upon the evidence of record.

IT IS HEREBY ORDERED that, no later than May 25, 2016, each of the intervenors to this matter shall file a statement as to whether there are any material issues of fact that warrant a hearing, along with a detailed description of those issues, or whether this case may be submitted for adjudication based on the existing record without a hearing.
