ORDER

This matter is before the Commission upon a June 8, 2016 motion filed by Sentra Corporation ("Sentra") requesting an extension of time from June 14, 2016, to June 21, 2016, to file responses to the supplemental requests for information of the Attorney General, by and through his Office of Rate Intervention, ("AG").

In addition, in order to give the parties sufficient time to determine whether to request a hearing, Sentra moves for an additional seven days to make such request, and that the parties be given until July 1, 2016, instead of June 24, 2016, to do so.

Having reviewed the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. The time within which a party may file a response to Sentra's June 8, 2016 motion pursuant to 807 KAR 5001, Section 5, has lapsed.

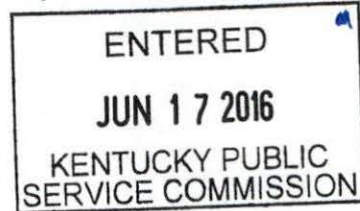
2. There is nothing in the record of this proceeding to indicate that Sentra's proposed date changes will prejudice the parties or disrupt the processing of this case.

IT IS THEREFORE ORDERED that:

1. Sentra's request for an extension time, until June 21, 2016, to submit its responses to the AG's supplemental request for information is granted.

2. The date for parties to make a filing indicating whether they desire a public hearing in this matter is extended from June 24, 2016, to July 1, 2016.
