ORDER

On October 21, 2010, in Case No. 2010-00116,<sup>1</sup> the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment clause.

On September 28, 2016, Delta filed its proposed Gas Cost Recovery ("GCR") rate application to be effective October 31, 2016.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$3.6367 per Mcf, which is a decrease of \$1.3337 per Mcf from the previous EGC of \$4.9704 per Mcf.
3. Delta's notice sets out no Refund Adjustment.

4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of \$.0691 per Mcf. Delta's total AA is \$.5953 per Mcf, which is an increase of \$.1162 per Mcf from the previous total AA of \$.4791 per Mcf.

5. Delta's notice sets out a current quarter Balance Adjustment ("BA") of (\$.2082) per Mcf. Delta's total BA is \$.1467 per Mcf, which is a decrease of \$.1925 per Mcf from the previous BA of \$.3392 per Mcf.

6. Delta's GCR rate is \$4.3787 per Mcf, which is a decrease of \$1.4100 per Mcf from the previous GCR rate of \$5.7887 per Mcf.

7. The rates as proposed by Delta and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after October 31, 2016.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Delta and set forth in the Appendix to this Order are approved for final meter readings on and after October 31, 2016.

2. Within 20 days of the date of this Order, Delta shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
