ORDER

On January 24, 2017, Big Rivers Electric Corporation filed a motion requesting permission to use the deposition of Gary Quick, which was conducted on June 13, 2011, in an arbitration proceeding involving Big Rivers and the city of Henderson, Kentucky, and the Henderson Utility Commission d/b/a Henderson Municipal Power & Light (jointly "Henderson"), docketed as American Arbitration Association Case No. 52 198 00173 10 ("Arbitration Matter").

Pursuant to 807 KAR 5:001, Section 5, which governs motion practice before the Commission, Henderson would have seven days from the date of Big Rivers' motion to file its response addressing Big Rivers' request, and Big Rivers, in turn, would have five days from the date Henderson files its response to file a reply in support of Big Rivers' motion. Since the formal hearing in this matter is scheduled for February 7, 2017, and a timely Order addressing Big Rivers' motion is needed prior to the upcoming hearing, the Commission will, pursuant to 807 KAR 5:001, Section 5, reduce the time period for the filing of a response and reply. The Commission finds that Henderson should have until January 27, 2017, to file its response and that Big Rivers should have until January 30, 2017, to file its reply.

IT IS HEREBY ORDERED that:

- Henderson shall file its response to Big Rivers' motion on or before
 January 27, 2017.
- Big Rivers shall file its reply in support of its motion on or before January
 30, 2017.
