### ORDER

On January 13, 2017, the Commission issued an Order establishing a procedural schedule for this proceeding. On January 24, 2017, Commission staff and the Office of the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("AG"), issued requests for information ("Information Requests") that required Nolin Rural Electric Cooperative Corporation ("Nolin") to file responses on or before February 7, 2017.

On February 3, 2017, Nolin filed a motion that requested an extension of time ("Motion") through February 17, 2017, in which to file its responses to the Information Requests. In support of the Motion, Nolin states that it needs additional time to file its responses due to the voluminous nature of the requests.

Having considered Nolin's Motion and being otherwise sufficiently advised, the Commission finds good cause to grant Nolin's Motion and to amend the procedural schedule to allow for an extension of time to file responses to the Information Requests, with dates of the remaining procedural steps modified accordingly.

## IT IS THEREFORE ORDERED that:

1. Nolin's Motion for extension of time is granted.

2. Nolin's responses to the information requested by Commission staff and the AG shall be filed on or before February 17, 2017.

3. The procedural schedule previously established in this matter is amended as set forth in the Appendix to this Order and shall be followed for the remainder of this proceeding.
