ORDER

On November 30, 2016, Bullitt Utilities, Inc. ("Bullitt Utilities"), by Robert W. Keats, Chapter 7 Trustee for Bullitt Utilities ("Trustee"), tendered for filing an application ("Application") for authority to implement a surcharge to pay for some of the extraordinary emergency costs incurred by Bullitt Utilities as a result of the catastrophic failure of its Hunters Hollow Wastewater Treatment Plant in 2014. In its Application, Bullitt Utilities requested that to the extent its Application did not meet minimum filing requirements, the Commission permit deviation from the requirements.

By Order entered December 29, 2016, the Commission found that the Application did not meet applicable minimum filing requirements. The Commission granted in part and denied in part Bullitt Utilities' request to deviate from the filing requirements. The Commission found that within ten days of the date of the Order, Bullitt Utilities should cure the filing deficiencies by filing the information identified in the Order. The Commission ordered that Bullitt Utilities' Application not be considered filed until all deficiencies are cured and the Commission has entered an Order accepting the Application for filing.

On January 9, 2017, Bullitt Utilities filed a motion for extension of time to file its response to the deficiencies identified in the Commission's December 29, 2016 Order

("Motion for Extension"). In support of its Motion for Extension, Bullitt Utilities states that the Trustee does not have all of the information requested by the Commission, and that Bullitt Utilities cannot address all deficiencies within ten days of the date of the Order. Bullitt Utilities requests a four-day extension of time, to January 13, 2017, to file its response.

Based on the Motion for Extension and being otherwise sufficiently advised, the Commission finds good cause to grant Bullitt Utilities an extension of time until January 13, 2017, to cure the deficiencies in its tendered surcharge application.

IT IS THEREFORE ORDERED that:

1. Bullitt Utilities' Motion for Extension is granted.

2. The Commission's December 29, 2016 Order is amended to the limited extent that Bullitt Utilities shall file by January 13, 2017, the information identified therein as necessary to meet minimum filing requirements.
