ORDER

This matter arises upon the motion Kentucky Power Company ("Kentucky Power"), filed on January 13, 2017, requesting an extension until January 20, 2017, in which to publish in the Elliott County News the notice required by 807 KAR 5:058, Section 10. In support of its motion, Kentucky Power asserts that 807 KAR 5:058, Section 10, requires Kentucky Power to publish notice of its 2016 Integrated Resource Plan ("IRP") within 30 days after the filing of the IRP. Kentucky Power notes that it filed its 2016 IRP on December 20, 2016, and, thus, notice is required to be published on or before January 19, 2017. Kentucky Power states that it provided the required notice to Kentucky Press Service, Inc. in time for the notice to be published in the newspapers of record in each of the 20 counties in its service territory. Kentucky Power also states that Kentucky Press Service, Inc. contacted each of the newspapers and arranged for the publication of the notice in each publication on or before January 17, 2017. Kentucky Power avers that it was informed on January 12, 2017, that, for reasons not known to Kentucky Power, the Elliott County News failed to publish the notice as scheduled and that it would publish the notice on January 20, 2017. Kentucky Power states that the one-day extension would not prejudice the public or the Commission and that it acted in good faith and with due care in arranging for the timely publication of notices.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Kentucky Power has established good cause to permit it a one-day extension in which to publish notice of its 2016 IRP in the Elliott County News.

IT IS HEREBY ORDERED that Kentucky Power's motion for a one-day extension of time to publish notice in the Elliott County News is granted.
