ORDER

On December 14, 2016, Dexter-Almo Heights Water District ("Dexter-Almo") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission notes that in its 2015 Annual Report, Dexter-Almo reported a water loss of 16.0093 percent. Commission regulation 807 KAR 5:066(6)(3) states that "for rate making purposes a utility's unaccounted-for water loss shall not exceed fifteen (15) percent of total water produced and purchased, excluding water used by a utility in its own operations."

The Commission strongly encourages Dexter-Almo to pursue reasonable actions to reduce its unaccounted-for water loss.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Dexter-Almo purchases water from the Murray Water and Sewer System ("Murray").

- 2. Murray notified Dexter-Almo that its wholesale rate to Dexter-Almo would increase from \$2.21 per 1,000 gallons to \$2.43 per 1,000 gallons effective January 1, 2017.² Dexter-Almo proposes to increase the water rates to its customers effective January 1, 2017, to reflect the increased cost of purchased water.
- 3. Dexter-Almo proposes a purchased water adjustment factor of \$0.28 per 1,000 gallons.
- 4. During the 12 months ended October 31, 2016, Dexter-Almo purchased 47,198,800 gallons of water from Murray. During the same period, Dexter-Almo sold 37,529,700 gallons of water. The increase in the cost of purchased water is \$10,383.73, resulting in a purchased water adjustment factor of \$0.28 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.28 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 6. Dexter-Almo's proposed rates as set forth in Appendix B to this Order are fair, just and reasonable and should be approved for water service rendered by Dexter-Almo on and after January 1, 2017.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.28 per 1,000 gallons is approved.
- 2. Dexter-Almo's proposed rates as set forth in Appendix B to this Order are approved for water service rendered by Dexter-Almo on and after January 1, 2017.

3. Within 20 days of the date of this Order, Dexter-Almo shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
