## ORDER

Pursuant to 807 KAR 5:056, the Commission, on February 6, 2017, established this case to review and evaluate the application of the Fuel Adjustment Clause ("FAC") of Jackson Energy Cooperative Corporation ("Jackson Energy") for the two-year period from November 1, 2014, through October 31, 2016.

As part of this review, the Commission ordered Jackson Energy to submit certain information and an affidavit attesting to its adherence to 807 KAR 5:056. The Commission further ordered that a public hearing be held in this case but cancelled it when, after publication of notice, no interested person advised the Commission of his or her intent to attend. Jackson Energy responded to two rounds of discovery. There are no intervenors in this proceeding.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that:

1. During the period under review, Jackson Energy has complied in all material respects with the provisions of 807 KAR 5:056.

East Kentucky Power Cooperative, Inc. ("East Kentucky"), the wholesale supplier of Jackson Energy, has been directed to reduce its base energy rates by \$.00238 per kilowatt-hour ("kWh") for fuel costs.<sup>1</sup>

Jackson Energy should be directed to reduce its base energy rates by
\$.00258 per kWh to reflect, as adjusted for line loss, the reduction by East Kentucky to
its base energy rates.

4. The rates and charges in the Appendix to this Order are fair, just, and reasonable, and reflect the reduction of fuel costs included in Jackson Energy's base energy rates.

IT IS THEREFORE ORDERED that:

1. The charges and credits applied by Jackson Energy through the FAC for the period from November 1, 2014, through October 31, 2016, are approved.

2. Jackson Energy shall deduct \$.00258 per kWh from its base energy rates (as adjusted for line loss) to reflect the reduction of \$.00238 per kWh by East Kentucky to its base energy rates as approved in Case No. 2017-00002.

3. The rates in the Appendix to this Order are approved for service rendered by Jackson Energy on and after September 1, 2017, the effective date of East Kentucky's change in rates.

4. Within 20 days of the date of this Order, Jackson Energy shall file, using the Commission's electronic Tariff Filing System, its revised tariff sheets with the
