## ORDER

On June 26, 2017, Louisville Gas and Electric Company ("LG&E") filed a motion to reschedule the hearing previously scheduled for July 12, 2017, due to irreconcilable scheduling conflicts of LG&E personnel involved in this matter. On June 29, 2017, the Commission entered an Order finding that LG&E had shown good cause to reschedule the hearing, and ordered the July 12, 2017 hearing continued until a later date, to be scheduled by the Commission. The Commission finds that the formal hearing in this matter should be rescheduled for November 8, 2017, at 8:30 a.m. and that, if necessary, the hearing should be continued on November 20, 2017.

## IT IS HEREBY ORDERED that:

1. LG&E shall appear on Wednesday, November 8, 2017, at 8:30 Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard in Frankfort, Kentucky, for the purpose of presenting evidence concerning the alleged violations of 49 C.F.R., Part 192, and of showing cause why it should not be subject to

the penalties prescribed in KRS 49 C.F.R., Part 192, for these alleged violations.

2. At the scheduled hearing in this matter, LG&E shall also present evidence on the adequacy, safety, and reasonableness of its practices related to the construction, installation, and repair of natural gas facilities, and whether such practices require revision as related to this incident.

3. The November 8, 2017 hearing shall be recorded by digital video recording only.
