ORDER

On November 21, 2017, the Commission entered an Order approving a rate adjustment for Letcher County Water and Sewer District ("Letcher County") and set forth the new rates and charges in the Appendix to that Order. Due to a clerical error, the Appendix included rates and charges from the Staff Report entered into the record on October 17, 2017, instead of the rates requested by the district. The leak adjustment rate remains \$4.43 per 1,000 gallons of water.

The Commission, having reviewed the record, finds that the correct monthly water rates are \$27.50 minimum bill for the first 2,000 gallons of water and \$7.50 per 1,000 gallons of water used thereafter. The Commission further finds that the November 21, 2017 Order should be amended to reflect the correct rates attached in the Appendix to this Order.

IT IS THEREFORE ORDERED, nunc pro tunc, that:

1. The Appendix to the November 21, 2017 Order is amended by deleting the erroneous monthly water rates of \$34.07 minimum bill for the first 2,000 gallons of water and \$9.30 per 1,000 gallons over 2,000 gallons of water, and adding the correct rates of

\$27.50 minimum bill for the first 2,000 gallons of water and \$7.50 per 1,000 gallons of water used over 2,000 gallons.

2. The rates set forth in the Appendix to this Order shall replace those set forth in the Appendix attached to the November 21, 2017 Order.
