# COMMONWEALTH OF KENTUCKY BEFORE THE PUBLIC SERVICE COMMISSION

#### ORDER

On February 16, 1995,<sup>1</sup> the Commission approved rates for Gasco Distribution Systems, Inc. ("Gasco") and provided for their further adjustment on a quarterly basis in accordance with Gasco's Gas Cost Adjustment clause.

On February 11, 2011, Navitas KY NG, LLC ("Navitas KY") acquired the assets of Gasco, pursuant to the Commission's approval of the transfer, and adopted Gasco's tariffs.<sup>2</sup>

On June 12, 2017, Navitas KY filed its proposed Gas Cost Recovery ("GCR") rate application to be effective August 1, 2017.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

 Navitas KY's notice includes revised rates designed to pass on to its customers its expected change in gas costs.

- Navitas KY's notice sets out an Expected Gas Cost ("EGC") of \$6.4114 per
   Mcf. which is a decrease of \$.3388 per Mcf from its previous EGC of \$6.7502 per Mcf.
  - Navitas KY's notice sets out no Refund Adjustment.
- 4. Navitas KY's notice sets out a current quarter Actual Cost Adjustment ("ACA") of \$.0040 per Mcf. Navitas KY's total ACA is \$.5064 per Mcf, which is an increase of \$.1434 per Mcf from its previous total ACA of \$.3630 per Mcf.
- 5. Navitas KY's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0605) per Mcf. Due to a spreadsheet rounding error, Navitas KY erroneously set out an incorrect total BA of (\$.4149) per Mcf. Navitas KY's corrected total BA is (\$.4150) per Mcf, which is a decrease of \$.0106 per Mcf from its previous total BA of (\$.4044) per Mcf.
- Navitas KY's corrected GCR rate is \$6.5028 per Mcf, which is a decrease
   \$1.2060 per Mcf from its previous GCR rate of \$6.7088 per Mcf.
- The rate set forth in the Appendix to this Order is fair, just, and reasonable,
   and should be approved for service rendered by Navitas KY on and after August 1, 2017.

#### IT IS THEREFORE ORDERED that:

- The rate proposed by Navitas KY is denied.
- The rate set forth in the Appendix to this Order is approved for service rendered by Navitas on and after August 1, 2017.

3. Within 20 days of the date of this Order, Navitas KY shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
