ORDER

On August 23, 2017, the Commission entered an Order granting Duke Energy Kentucky, Inc. ("Duke Kentucky") authority to adjust its gas supply cost. Among other things, the August 23, 2017 Order approved a revised Gas Cost Adjustment Transition (GCAT) rate of (\$.1030) per ccf. After the final Order was issued, Duke filed a revised GCAT rate of (\$.01030) per ccf and explained that the originally filed GCAT rate was based on 1,000 cubic feet rather than 100 cubic feet. The Commission has reviewed Duke Kentucky's application and supplemental GCAT rate and finds that Duke Kentucky's GCAT rate should be (\$.01030) per ccf for the period September 2017 through November 2017.

The Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Finding paragraph 7 of the August 23, 2017 Order in this matter is amended to read as follows:

7. Duke's notice sets out a Gas Cost Adjustment Transition ("GCAT") Rider rate of (\$.01030) per 100 cubic feet. This GCAT rate will be applicable to customers who begin receiving Rate FT-L transportation service after the effective date of this Order who paid gas supply costs through the GCA during the 12-month period before they began receiving FT-L service.

2. The Appendix to the August 23, 2017 Order in this matter is amended, in part, to read as follows:

RIDER GCAT
GAS COST ADJUSTMENT TRANSITION RIDER


The amount of this charge or (credit) shall be (\$.01030) per 100 cubic feet. This rate shall be in effect during the months of September 2017 through November 2017 and shall be updated quarterly, concurrent with the Company's GCA filings.

3. All other provisions of the August 23, 2017 Order shall remain in full force and effect.
