ORDER

On January 13, 1992, in Case No. 1991-00127, the Commission approved certain adjusted rates for B&H Gas Company (“B&H”).¹ On May 4, 2017, the Commission approved changes to B&H’s Purchased Gas Adjustment (“PGA”) clause in Case No. 2015-00367.² Those changes updated the methodology of calculating the components of B&H’s gas cost via a Gas Cost Recovery (“GCR”) rate mechanism.

On August 31, 2017, B&H filed its GCR rate application with rates proposed to be effective October 1, 2017. On September 25, 2017, B&H filed a revised application.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. B&H’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs from its supplier B&S Oil & Gas Company, an affiliate pursuant to KRS 278.010(18).

2. B&H's notice sets out an Expected Gas Cost ("EGC") of \$5.4410 per Mcf, which was calculated by applying the Commission's methodology for setting B&S's market price to B&H as required in Case No. 2015-00367. This represents a decrease of \$.5475 per Mcf from the EGC found reasonable by the Commission in Case No. 2015-00367.

3. B&H's August 31, 2017 notice sets out the Refund Adjustment ("RA") of (\$3.0000) per Mcf as required by the Commission in Case No. 2015-00367. B&H had appealed the Commission's Orders in Case No. 2015-00367 to Franklin Circuit Court, and moved the Circuit Court to enjoin temporarily the RA from going into effect pending a final adjudication of the appeal.³ On September 19, 2017, the Franklin Circuit Court granted a temporary stay of the implementation of the (\$3.0000) per Mcf RA pending final adjudication of B&H's appeal of the Commission's final Order in Case No. 2015-00367. Accordingly, the RA will not be included in B&H's October 1, 2017 GCR rate.

4. B&H's GCR rate is \$5.4410 per Mcf.

5. The rates as proposed by B&H in its September 25, 2017 revised application and set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by B&H on and after October 1, 2017.

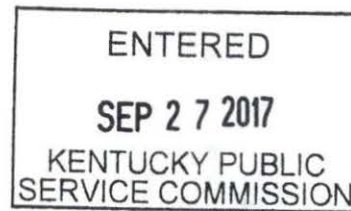
IT IS THEREFORE ORDERED that:

1. The rates proposed by B&H and set forth in the Appendix to this Order are approved for service rendered on and after October 1, 2017.


