ORDER

On December 27, 2017, Competitive Carriers of the South, Inc. (“CompSouth”) filed a motion to allow Windstream Communications, Inc. (“Windstream”) to substitute for CompSouth as a party in this matter. CompSouth was an organization of several telecommunications carriers of which Windstream was a member. As grounds for its motion, CompSouth states that during the course of the proceeding before the Commission, all members of CompSouth, except for Windstream, have withdrawn from CompSouth, and CompSouth formally dissolved on December 31, 2017.

The Commission finds that CompSouth has provided sufficient grounds to sustain its motion.

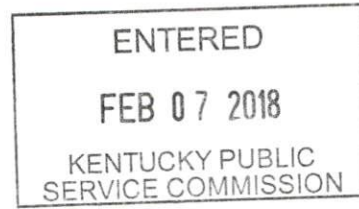
IT IS HEREBY ORDERED that:
