ORDER

On December 19, 2017, the Commission entered a final Order in this matter that, *inter alia*, authorized Louisville Gas and Electric Company ("LG&E") to utilize a weighted average cost of capital ("WACC") of 7.04 percent, an income tax gross-up factor of 0.61334, and an overall grossed-up rate of return of 10.34 percent for environmental surcharge filings beginning in the second full-billing month after the date of the Order. On December 20, 2017, the Tax Cuts and Jobs Act ("Tax Act") was passed by both chambers of the United States Congress; it was signed into law on December 22, 2017. On January 8, 2018, LG&E filed a Motion for Reconsideration, and requested the Commission amend its December 19, 2017 Order to approve a tax gross-up factor of 0.745444 to reflect the reduction in the corporate income tax rates included in the Tax Act. LG&E's WACC of 7.04 percent and the gross-up factor of 0.745444 results in an overall grossed-up rate of return of 8.83 percent. LG&E proposes to use the revised rate of return beginning with the January 2018 expense month.

Having considered LG&E's Motion for Reconsideration and being otherwise sufficiently advised, the Commission finds that LG&E has established good cause to

revise the gross-up factor and overall grossed-up rate of return for environmental surcharge purposes. The remainder of the December 19, 2017 Order will remain in effect.

IT IS THEREFORE ORDERED that:

- LG&E's Motion for Reconsideration is granted.
- 2. LG&E shall use an overall rate of return on capital of 7.04 percent, a return-on-equity rate of 9.70 percent, a tax gross-up factor of 0.745444, and an overall grossed-up return of 8.83 percent in all monthly environmental surcharge filings beginning with the January 2018 expense month.
- All other provisions of the Commission's December 19, 2017 Order that are not in conflict with this Order shall remain in full force and effect.
