ORDER

On March 26, 2018, Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") (collectively "LG&E/KU") filed a joint motion requesting that the existing procedural schedule established on January 4, 2018, be amended to afford them an opportunity to file rebuttal testimony by April 24, 2018. LG&E/KU note that under the existing procedural schedule, intervenor testimony has been filed, dates are established for discovery on intervenors, and all parties have until April 26, 2018, to either request an evidentiary hearing or submit this case upon the record. LG&E/KU assert that their filing of rebuttal testimony by April 24, 2018, will help narrow the issues in this case and afford the other parties adequate time to determine whether to request an evidentiary hearing.

Based on the joint motion and being otherwise sufficiently advised, the Commission finds good cause to permit LG&E/KU to file rebuttal testimony as requested.

IT IS THEREFORE ORDERED that:

1. The LG&E/KU joint motion to file rebuttal testimony is granted.

- 2. The procedural schedule established by the Commission's Order entered on January 4, 2018, is amended to the limited extent that LG&E/KU shall file rebuttal testimony, if any, in verified prepared form no later than April 24, 2018.
- All other provisions of the Commission's Order entered on January 4,
 2018, shall remain in full force and effect.
