ORDER

On April 29, 2004, in Case No. 2003-00411,¹ the Commission approved rates for Equitable Gas Company, a division of Equitable Resources, Inc. ("Equitable"), and provided for their further adjustment on a quarterly basis in accordance with Equitable's Purchased Gas Adjustment clause. Equitable is regulated pursuant to KRS 278.485 and 807 KAR 5:026, the statute and regulation governing gathering systems that provide service to retail customers who tap onto such systems. Peoples Gas KY, LLC ("Peoples") acquired Equitable on December 17, 2013.

On December 28, 2017, Peoples filed its proposed Gas Cost Recovery ("GCR") rate application, to be effective February 1, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

 Peoples' notice includes a revised rate designed to pass on to its customers its expected change in gas costs.

- 2. Peoples' Expected Gas Cost ("EGC") is \$3.4486 per Mcf, which is a decrease of \$.6932 per Mcf from its previous EGC of \$4.1418 per Mcf.
 - 3. Peoples' notice sets out no Refund Adjustment.
- 4. Peoples' notice sets out a current quarter Actual Cost Adjustment ("ACA") of \$.0825 per Mcf. Peoples' total ACA is \$.2106 per Mcf, which is an increase of \$.0211 per Mcf from the previous total ACA of \$.1895 per Mcf.
- 5. Peoples' notice sets out a current quarter Balance Adjustment ("BA") of \$.0046 per Mcf. Peoples' total BA is (\$.0912) per Mcf, which is a decrease of \$.0094 per Mcf from the previous total BA of (\$.0818) per Mcf.
- 6. Peoples' GCR rate is \$3.5680 per Mcf, which is a decrease of \$.6815 per Mcf from its previous rate of \$4.2495 per Mcf.
- 7. The rate as proposed by Peoples and set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for final meter readings by Peoples on and after February 1, 2018.

IT IS THEREFORE ORDERED that:

- 1. The rate proposed by Peoples and set forth in the Appendix to this Order is approved for final meter readings on and after February 1, 2018.
- Within 20 days of the date of entry of this Order, Peoples shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
