ORDER

Pursuant to 807 KAR 5:056, the Commission established this case on February 16, 2018, to review and evaluate the operation of the Fuel Adjustment Clause ("FAC") of East Kentucky Power Cooperative, Inc. ("East Kentucky") for the six-month period that ended on October 31, 2017. As part of this review, East Kentucky responded to two requests for information and the Commission held a formal hearing in this matter on April 18, 2018. On April 27, 2018, East Kentucky filed its response to the Commission Staff's post-hearing data request.

A review of East Kentucky's monthly FAC filings shows that the fuel cost billed for the six-month period under review ranged from a low of \$.02310 per kWh in August 2017, to a high of \$.02509 per kWh in both May and September 2017, with a six-month average of \$.02437 per kWh.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds no evidence of improper calculation or application of East Kentucky's FAC charges or improper fuel procurement practices.

IT IS THEREFORE ORDERED that:

- The charges and credits billed by East Kentucky through its FAC for the period May 1, 2017, through October 31, 2017, are approved.
