ORDER

This matter arises upon the joint motion of Big Sandy Rural Electric Cooperative Corporation, Blue Grass Energy Cooperative Corporation, Clark Energy Cooperative, Inc., Farmers Rural Electric Cooperative Corporation, Fleming-Mason Energy Cooperative, Inc., Inter-County Energy Cooperative Corporation, Licking Valley Rural Electric Cooperative Corporation, and Nolin Rural Electric Cooperative Corporation ("collectively the "Companies"), filed February 23, 2018, for full intervention. - The Companies shall comply with all provisions of the Commission's regulation, 807 KAR 5:001, Section 7, related to the service and filing of documents.
- 4. The Companies shall adhere to the procedural schedule set forth in the Commission's February 19, 2018 Order and as amended by subsequent Orders.
- 5. Within seven days of entry of this Order, the Companies shall provide their electronic mail address to which all electronic documents issued by the Commission and other parties of record may be served upon the Companies in accordance with 807 KAR 5:001, Section 4(8).
