### ORDER

This matter arises upon the motion of South Kentucky Rural Electric Cooperative Corporation ("South Kentucky") filed March 5, 2018, requesting a five-day extension of time in which to file responses to requests for information. Pursuant to the procedural schedule that the Commission established by Order entered February 19, 2018, South Kentucky's responses were to be filed no later than March 7, 2018. Granting South Kentucky's request, therefore, will extend the deadline to March 12, 2018.

As grounds for its motion, South Kentucky states that it has received five individual requests for information, which includes 272 total items. However, South Kentucky's current counsel has identified a direct legal conflict requiring withdrawal from representation of South Kentucky in this matter. South Kentucky states that it is in the process of retaining substitute counsel, but due to the quantity, detail, and complexity of the requests for information, it requires a brief extension of time to prepare and file the necessary responses.

The Commission finds that South Kentucky has provided good cause and its motion should be granted. South Kentucky, however, had requested an expedited

procedural schedule in this matter. The Commission, in establishing the procedural schedule, set short deadlines and the granting of South Kentucky's request for an extension will necessitate that those dates change as well. Accordingly, in granting South Kentucky's request, the Commission will also be issuing a revised procedural schedule.

#### IT IS HEREBY ORDERED that:

- South Kentucky's Motion is granted.
- The procedural scheduled established in the Commission's February 19,
   Order is vacated.
- All parties shall adhere to the procedural schedule established in the Appendix to this Order.
