ORDER

This matter arises upon a motion filed by Salt River Electric Cooperative Corporation (Salt River Electric) to strike portions of East Kentucky Power Cooperative, Inc.'s (EKPC) post-hearing brief. Pursuant to a post-hearing scheduling Order (Scheduling Order) issued May 18, 2018, this case was to stand submitted for a decision by the Commission effective 12:01 a.m., Eastern Daylight Time, on July 24, 2018.

The Commission, on its own motion, finds that the evidentiary record should remain open to permit the parties to respond to Salt River Electric's motion to strike, and for Salt River Electric to file a reply to any responses to its motion to strike. Pursuant to 807 KAR 5:001, Section 5(3), any reply filed by Salt River Electric "shall be confined to points raised in the responses to which they are addressed, and shall not reiterate an argument already presented."

IT IS THEREFORE ORDERED that:

1. Any party wishing to file a response to Salt River Electric's motion to strike shall file its response no later than July 31, 2018.

2. Salt River Electric shall file its reply to responses to its motion to strike no later than August 7, 2018.

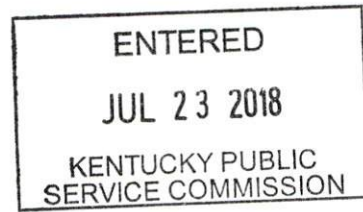
3. Ordering paragraph 6 of the May 18, 2018 Scheduling Order establishing a post-hearing procedural schedule is stricken and replaced with the following:

This case shall stand submitted for a decision by the Commission effective 12:01 a.m., Eastern Daylight Time, on August 8, 2018.

4. All provisions of the May 18, 2018 Scheduling Order that do not conflict with this Order shall remain in full force and effect.
