ORDER

On February 28, 2018, Louisville Gas and Electric Company ("LG&E") submitted an application requesting to revise rates for its Gas Line Tracker Adjustment Clause ("GLT") effective May 1, 2018, pursuant to the Commission's Order in Case No. 2012-00222¹ approving the GLT program and associated rates. LG&E responded to one round of requests for information from Commission Staff. There are no intervenors in this proceeding. The case now stands submitted for decision.

LG&E's revenue requirement eligible for recovery under its GLT mechanism for 2018 is \$6,947,242. Of that amount, \$5,302,757 is related to distribution projects, with the remaining \$1,644,485 being related to transmission projects. During 2017, LG&E had a total over-collection of \$2,182,332 which it proposes to include as a credit to its 2018 revenue requirement in order to refund the over-collected amounts to its customers through its GLT balancing adjustment for 2017.

Having reviewed the evidence of record and being otherwise sufficiently advised, the Commission finds that the information contained in LG&E's filing is in sufficient detail to support the reasonableness of LG&E's revised GLT rates.

IT IS HEREBY ORDERED that:

- 1. The GLT rates in the Appendix to this Order are approved for service rendered by LG&E on and after May 1, 2018.
- 2. Within 20 days of the date of entry of this Order, LG&E shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - 3. This case is closed and removed from the Commission's docket.
