ORDER

On October 18, 2017, in Case No. 2017-00074,¹ the Commission approved rates for gas service for Western Lewis-Rectorville Water and Gas District (“Western Lewis”) and provided for their further adjustment in accordance with Western Lewis’s Gas Cost Adjustment clause.

On February 26, 2018, Western Lewis filed its proposed Gas Cost Recovery (“GCR”) rate to be effective April 1, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Western Lewis’s notice includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Western Lewis’s notice sets out an Expected Gas Cost (“EGC”) of \$4.1719 per Mcf, which is an increase of \$.0508 per Mcf from its previous EGC of \$4.1211 per Mcf.
3. Western Lewis’s notice sets out a Refund Adjustment (“RA”) of (\$1.2500) per Mcf, which is no change from its previous RA.

4. Western Lewis's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0005) per Mcf. Western Lewis's total AA is (\$2.0151) per Mcf, which is a decrease of \$.0005 per Mcf from its previous total AA of (\$2.0146) per Mcf.

5. Western Lewis's notice sets out no current quarter Balance Adjustment ("BA") and no total BA.

6. Western Lewis's GCR rate is \$.9068 per Mcf, which is an increase of \$.0503 per Mcf from the previous GCR rate of \$.8565 per Mcf.

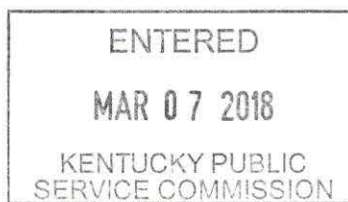
7. The rates as proposed by Western Lewis and set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by Western Lewis on and after April 1, 2018.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Western Lewis and set forth in the Appendix to this Order are approved for service rendered by Western Lewis on and after April 1, 2018.

2. Within 20 days of the date of entry of this Order, Western Lewis shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
