ORDER

On May 3, 2018, Jessamine-South Elkhorn Water District ("Jessamine-South Elkhorn") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Jessamine-South Elkhorn purchases water from the Kentucky-American Water Company ("Kentucky-American"), the City of Nicholasville ("Nicholasville") and the City of Wilmore ("Wilmore").

2. Kentucky-American notified Jessamine-South Elkhorn that its wholesale rate would increase from \$4.486 per 1,000 gallons to \$4.503 per 1,000 gallons effective March 31, 2018.² Jessamine-South Elkhorn proposes to increase the water rates to its customers effective March 31, 2018, to reflect the increased cost of purchased water from Kentucky-American.

 Jessamine-South Elkhorn proposed a purchased water adjustment factor of \$0.02 per 1,000 gallons.

4. During the 12 months ended January 31, 2018, Jessamine-South Elkhorn purchased 231,059,444 gallons of water from Kentucky-American, 21,383,300 gallons of water from Nicholasville, and 17,440 gallons of water from Wilmore. During the same period, Jessamine-South Elkhorn sold 226,186,059 gallons of water. The increase in the cost of purchased water is \$ 3,298.01, resulting in a purchased water adjustment factor of \$0.02 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.02 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. Jessamine-South Elkhorn proposed to increase water service rates to its customers effective March 31, 2018. The Commission notes that Jessamine-South Elkhorn's application does not comply with the requirements of KAR 5:068, Section 4.(2)(b). Pursuant to KAR 5:068, Section 8, the Commission shall grant a deviation from the requirements of KAR 5:068, Section 4.(2)(b) and shall allow the rates as set forth in Appendix B to this Order to go into effect on and after the date of this Order.

7. Jessamine-South Elkhorn's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered by Jessamine-South Elkhorn on and after the date of this Order.

IT IS THEREFORE ORDERED that:

 The rates proposed in the application by Jessamine-South Elkhorn are approved.

2. The purchased water adjustment factor of \$0.02 per 1,000 gallons is approved.

3. The proposed March 31, 2018 effective date is denied.

4. The rates as set forth in Appendix B to this Order are approved for water service rendered by Jessamine-South Elkhorn on and after the date of this Order.

5. Within 20 days of the date of this Order, Jessamine-South Elkhorn shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
